RENTAL INFORMATION		
<p>WARA rentals are on a first-come, first-served basis. Along with a completed contract, the Renter is required to pay the rental fee as checked below <u>prior</u> to the event time. Parties will not be scheduled on July 4 or days reserved for WARA activities including late night swims. Please know that Memorial Weekend and Labor Day weekend are extremely busy and parties scheduled will be up to the discretion of the pool manager during pool hours.</p>

1. The Renter who's name appears on the rental contract must be a Stock Member of WARA and must be ON-SITE during the entire rental function. Any function for those under the age of 18 must have adult supervision at all times.
2. The Renter MAY NOT charge admittance to the facility during the rental.
3. Attendance at the event may not exceed the number specified in this contract.
4. There is NO SMOKING or VAPING permitted anywhere on WARA property.
5. Glass is not permitted under the pavilion or on the pool deck; this includes bottles and dishes used by caterers.
6. Set-Up and Clean-Up Policy: All party set-up and clean-up must take place within 30 minutes of your reserved party times. The renter is responsible for ensuring the reserved party area is clean and returned to its original condition. This includes, but is not limited to removing all decorations, food, and personal items and placing all trash in the designated trash receptacles. All guests and belongings must vacate the party area by the end of the reserved time.
7. Damage Responsibility Policy: The renter assumes responsibility for any damage to tables, chairs, facility property, or equipment caused by the renter or their guests during the reservation period. Repair or replacement costs may be charged if damage occurs.
8. Cancellation Policy: Cancellations made within 48 hours of the scheduled reservation are non-refundable.
9. WARA Personnel have the right to be present or visit the facility during the rental to make sure all the rules and policies are being followed. If during the visit, WARA Management finds any rules violations, the Manager of Duty will enforce such rules or shut the party down.
10. In compliance with Campbell County Noise Ordinance, all rentals are required to play any music in moderation so that it does not disturb area residents. If noise complaints are made or staff has had to repeatedly request that the volume be lowered, WARA reserves the right to terminate the Renter's contract without any refund. The Noise Ordinance is strictly enforced after 11:00 p.m. It is the Renter's responsibility to make any contracted workers aware of this county policy and understand that the county sheriff has the authority to terminate the event should said event become too loud or unruly.
11. WARA will not be responsible for any Acts of God such as extreme high or low temperatures, winds, hurricanes, power failures, flooding or fire. We take every precaution to provide a safe, comfortable and enjoyable environment for unknown circumstances or acts beyond our control. If bad weather prevents the party from taking place, a full refund will be issued if it cannot be rescheduled.
